The date and time of the Course Workshop was selected by Handler on the Dog Training for Owners website. The fee for the Workshop is \$119. Payment shall be made in advance and is non-refundable.

Therapy Dog Handler Course

The Course will be taught by a Licensed Pet Partners Instructor, and covers policies, procedures, and skills necessary to safely visit with Handler's dog in environments such as hospitals, nursing homes, classrooms, libraries, mental institutions, correctional facilities, and more. The course will be held over an 8-hour period. Completion of the Course does not guarantee that Handler's dog is suitable for therapy work; a separate evaluation is required to provide such an assessment.

Health and Safety

Dog Training for Owners will do everything it reasonably can to conduct the Course in a manner that is safe for the Handler, any animals that may be present, and other people. While many factors are beyond the control of Dog Training for Owners, the below terms and conditions are aimed to help ensure a healthy and safe environment, within reason.

I acknowledge that Therapy Dogs may be present at the Course and agree that the risks involved include, but are not limited to, myself contracting a communicable disease or being bitten.

I hereby hold Pet Partners, Pet Partners Instructors and Dog Training for Owners harmless of any liability for my dog or any of my dog's actions including, but not limited to, intentional or unintentional actions that cause harm or loss to a human being, animal, or property at any time in the future.

Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his/her award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
